

**EDUCATIONAL PURPOSE FORM**  
**Application to process only a**  
**Federal PLUS (parent) Loan.**

While Pennsylvania College of Technology recommends that all families complete the [Free Application for Federal Student Aid \(FAFSA\)](#), some families may choose to apply for the Federal PLUS (Parent) Loan without completing the FAFSA.

Federal regulations require that all students receiving any type of Federal Title IV funds must sign a statement of Educational Purpose and [Selective Service Registration](#). Parents receiving Federal PLUS loan funds must also sign a statement of Educational Purpose. Since your family will not complete a FAFSA which includes this information, we need this statement on file. As with the FAFSA, **this form must be completed each year a family wishes to borrow.**

Student's Statement of Educational Purpose:
