PATHWAY AGREEMENT BETWEEN

PENNSYLVANIA COLLEGE OF TECHNOLOGY

AND

HUNTINGDON COUNTY CAREER & TECHNICAL CENTER

This agreement establishes a mechanism for students of **Huntingdon County Career & Technical Center** to earn credit for the below defined coursework at Penn College in **Physical Therapist Assistant**.

Students completing **Huntingdon County Career & Technical Center** and its **Sports, Exercise and Rehabilitation Therapy** curriculum, which includes job shadowing experience, will receive credit for up to 10 clinical observation hours if completed in one physical therapy setting (e.g., outpatient, inpatient, long-term care, home health) and up to 20 clinical observation hours if completed in two physical therapy settings upon submission of appropriate documentation. Hours can be split any way between settings. If the student receives credit for 10 clinical observation hours in one setting, the student will be responsible for completing the remaining 10 clinical observation hours in another setting to be eligible for ranking and selection into the Physical Therapist Assistant program. All documented hours must be submitted to Penn College's PTA Program office (pta@pct.edu) by December 1 of the selection year.

Students successfully completing **Huntingdon County Career & Technical Center** and its **Sports, Exercise and Rehabilitation Therapy** curriculum with a cumulative high school GPA of 3.0 or higher (or equivalent) and who are eligible for the selective admission process for the PTA program will receive 2 additional points toward the competitive <u>ranking process</u>.

Additional Transfer Information

- Students must have gained admission to Penn College and met placement requirements to enroll as a pre-PTA student.
- Students must complete coursework with a grade of C or better (2.0 or better on a 4.0 scale).
- Penn College will accept **Huntingdon County Career & Technical Center** coursework for Penn College credit for students who enroll at the College within two (2) academic years of graduation from **Huntingdon County Career & Technical Center**.
- Students must submit the following to Penn College prior to enrollment to receive credit for their **Huntingdon County Career & Technical Center** program:
 - their final official Huntingdon County Career & Technical Center transcript
 - the Huntingdon County Career & Technical Center Articulation Agreement Completion Form, completed and signed by Huntingdon County Career & Technical Center administrators, noting completion of specific competencies, job shadowing, and coursework

- o the Penn College PTA Clinical Observation Form to the PTA Program Office
- Penn College will only consider those credits earned through **Huntingdon County Career & Technical Center** for the terms of this agreement. Students must request transcripts from additional institutions to be evaluated on an individual basis at Penn College.
- Credits will post on the student's official academic transcript upon the successful completion of twelve (12) credits of academic work at Penn College. Prior to completion of twelve (12) credits, for advising and scheduling purposes, approved credits will show on working copies of the student's academic transcript and on the student's graduation profile. Whether Penn College credits will be accepted by another college or university is at the discretion of the receiving college or university.
- Completion of Huntingdon County Career & Technical Center's program and admittance to Penn College as a pre-PTA student does not guarantee selection into the PTA program. <u>All</u> <u>selective admission criteria for the PTA program</u> will apply.
