Scholarship Opportunities

Graduates from a state-approved CTE program can land a \$2,000 annual scholarship—renewable for up to four years. As long as you meet minimum criteria like enrolling full-time and earning a 2.0 cumulative high school GPA, you'll receive this award. Tuition-Free Credits

Just by participating in a CTE program and enrolling at Penn College, you can earn credits by testing out of any 100- or 200-level course. This is on top of the credits you can get from other agreements.

Advanced & Alternative Credits

You can also fast-track your future by taking advantage of advanced and alternative credit opportunities. These include earning credits by passing competency assessments and through licensure or specific work or life situations.

Accelerated Pathways

If your school doesn't already have a formal pathway with us, you'll be awarded three credits just by meeting Career & Technical Education Student Scholarship requirements. These can be applied to most bachelor's degrees, whether you start with an associate's and transfer into a bachelor's or dive into a bachelor's from the start.
