8. Comments from the President

President Reed shared the following with the group:

- Thanked Joe Yoder for his leadership and service as Associate Vice President for Public Relations & Marketing. Joe Yoder retired on June 30, 2025.
- Officially welcomed Katie Bell as the Vice President for Communications & Marketing.
- Thanked the team for an exceptional year: Placement rate, recruitment, retention, Workforce, College Relations, Athletics, US News & World Report Rankings.
- Completed New Student Orientation number five of nine earlier in the day.
- Enrollment drives nearly all campus operations, and it is shaping up to be another strong enrollment year. This is of significant importance because the industry needs more Penn College graduates. As of June 25, deposits were +9%, YTD.
- The Penn College Foundations' 39th Annual Golf Classic was held on June 23, 2025, and raised \$106,900 for student scholarships.
- The Baja team earned a ninth-place showing out of 84 schools in the recent endurance race at Mechanicsville, Maryland, outperforming the majority of institutions commonly referenced as elite
- General Services: Reviewed the Construction projects and thoughtful energy usage reductions.

Senator Yaw commented on the new ballfield complex going up near Interstate 180 – a Williamsport/Lycoming Chamber of Commerce project – which will be used by the Penn College baseball and softball teams. "He said, "The project is expected to attract 250,000 visitors to the area annually."

Senator Yaw referenced the recent development on Maynard Street at the college's main entrance, which now features a new Wawa, the existing Sheetz store, and a Chick-fil-A being constructed nearby. Also mentioning the Bass Pro Shops store that is due to be constructed at the former Lycoming Mall property, Yaw said, "It's an exciting time for the college to be located where it is."
