# WELCOME

## to Penn College Dual Enrollment

Congratulations on your decision to take Penn College Dual Enrollment coursework! The information in this guide is intended to introduce you to Penn College Dual Enrollment and its policies and procedures.

Through Penn College Dual Enrollment, you can earn Pennsylvania College of Technology credits while in high school. **Penn College Dual Enrollment courses are actual Penn College courses**, taught at your high school or career and technology center (CTC) by your teachers. Most importantly, Penn College Dual Enrollment courses cost nothing. Sometimes you might need to pay for books or materials, but it's much less than the cost of a typical college course.

Students who successfully complete Penn College Dual Enrollment courses **earn Pennsylvania College of Technology credits**. At Penn College, students only pay for the number of credits they take. That means that every Penn College Dual Enrollment credit earned in high school is like a \$608 scholarship to Penn College. And that adds up. Earning three credits saves you over \$1,800 in tuition at Penn College!

## INCREASING YOUR ODDS OF SUCCESS IN COLLEGE

No matter which major or degree you choose, if you have already been successful in college courses and are familiar with a college campus before entering college, you’re more likely to stay in college once you enroll after graduation. And you’re more likely to complete your chosen degree.

In order to be eligible for Penn College Dual Enrollment courses, you **must** attend one of our partner high schools or CTCs, and must:

— ♦ Be a student in 11th or 12th grade.

- ♦ MTR100: Medical Terminology Survey
- ♦ PPT115: The Plastics Industry
- ♦ WEL119: Shielded Metal Arc Welding

*These courses are only open to 12th grade students:*

- ♦ ENL111: English Composition I
- ♦ MTH123: Technical Algebra and Trigonometry I

— ♦ Complete the free Penn College Dual Enrollment application through your high school or CTC.

— ♦ Meet academic qualifications, like minimum GPA requirements, and placement assessments. Check with a Penn College Dual Enrollment teacher or your school counselor for more info on specific requirements.

**Please note** that your high school or CTC may have additional eligibility requirements for participation in Penn College Dual Enrollment. Check with your school or CTC to find out.

## ELIGIBILITY FOR PENN COLLEGE DUAL ENROLLMENT

# If you're a Penn College Dual Enrollment student, you ARE a Penn College student.

As a student taking Penn College Dual Enrollment courses, you're taking college coursework for college credit. You're given a Penn College student identification number, system username, and system password.

And as a Penn College student, there are some things you need to know.

**YOUR ATTENDANCE IS EXTREMELY IMPORTANT.** Being present and prepared in your classroom or lab will increase your chance for success in every course. This is especially true when it comes to Penn College Dual Enrollment coursework. Be aware that **excessive absences, even if excused, may result in your removal** from the program.

**PENN COLLEGE DUAL ENROLLMENT COURSES ARE ACTUAL PENNSYLVANIA COLLEGE OF TECHNOLOGY COURSES,** offered to high school students. What you get at your high school or CTC in a Penn College Dual Enrollment course is what an on-campus student at Penn College receives as well.



**THE FINAL EXAM FOR YOUR PENN COLLEGE DUAL ENROLLMENT COURSE IS THE SAME FINAL USED AT PENN COLLEGE FOR THAT COURSE.** Often, your other exams and projects will be the same, too.

- ◇ Because your secondary teacher can add things like homework and participation to your high school or CTC grade on your report card (which are not included in a Penn College course grade), **your school or CTC grade is usually different than your Penn College Dual Enrollment final course grade** (which can only be made up of exams, projects, etc. that are listed on the Penn College course syllabus).
- ◇ Your Penn College Dual Enrollment credits will appear on your Penn College transcript. **Every Penn College Dual Enrollment course counts toward at least one Penn College degree.** Should you choose not to attend Penn College after graduation, you can contact your college/university to check on transferring your Penn College credits.

**AN "F" OR A "W" IN A PENN COLLEGE DUAL ENROLLMENT COURSE IS AN "F" OR "W" ON AN OFFICIAL COLLEGE TRANSCRIPT!** An "F" OR "W" can affect your GPA and your ability to get financial aid once you enroll in college after high school. For those seeking entry into selective admissions programs (often in health science majors), an "F" or "W" may impact your eligibility and ranking for selection.

Students who plan to attend Penn College after graduation are eligible for Penn College Dual Enrollment scholarships in the amounts of **\$1,000** (10 available) and **\$4,000** (one available, renewable up to four years).

*Students must meet the following minimum qualifications:*

- ◇ Complete at least one Penn College Dual Enrollment course (of any credit value) with a minimum GPA of 3.0 in the course.
- ◇ Submit the Penn College Scholarship application.
- ◇ Enroll in Penn College as a full-time freshman student, for the fall semester after high school graduation.
- ◇ As an enrolled student at Penn College, maintain a minimum 2.5 cumulative GPA.
- ◇ Complete the essay in the Penn College scholarship application.

Penn College Dual Enrollment is proud to partner with the First Community Foundation Partnership of PA to offer an additional scholarship in the amount of **\$3,000**, sponsored by the Ben Franklin Trust Fund.

*Students must meet the following minimum qualifications:*

- ◇ Currently enrolled as a high school student in a career and technical education program located in Bradford, Clinton, Lycoming, Potter, Sullivan, or Tioga county.
- ◇ Possess a high school cumulative GPA of a "B" or higher.
- ◇ Submit the essay within the Penn College scholarship application.
- ◇ Enroll in Penn College as a full-time student in the fall semester after high school graduation.

Penn College is proud to offer the Career & Technical Education Student Scholarship, which is a **\$2,000** yearly renewable award.

*Successful applicants must meet the following minimum qualifications:*

- ◇ Be a Pennsylvania, New York, New Jersey, Maryland, or Connecticut resident.
- ◇ Enroll as a first-time, full-time student.
- ◇ Have completed a minimum of one year (or 360 hours) in a Pennsylvania Department of Education approved Career and Technical Education (CTE) program.
- ◇ Earn a 2.0 cumulative GPA for all CTE completed coursework.
- ◇ Submit the Penn College Scholarship Application..
- ◇ Submit final, official CTC/CTE transcript to the Admissions Office.

Students must complete the following steps by **April 1 of their senior year** in order to be considered for any of the above scholarships:

- ◇ Complete an application to Penn College enrollment.
- ◇ Meet College placement requirements, submit valid SAT scores, and/or submit coursework from another college).
- ◇ Confirm intent to enroll and make the tuition deposit.
- ◇ Complete the Penn College scholarship application.
  - ◇ Write the required essay. Use spellcheck, grammar check, and have someone proofread for errors.
  - ◇ Note that one application covers every scholarship at Penn College, so completing it puts a student in the running for every scholarship for which they are eligible (including, but not limited to, all scholarships above).
- ◇ Complete the FAFSA.

Students must complete the **Penn College Scholarship Application** in order to be considered for any scholarship ([pct.edu/scholarships](http://pct.edu/scholarships)).

## ACCEPTABLE USE OF TECHNOLOGY

**You will receive a Penn College ID number, username, and password for use of our Student Information System (SIS) and online resources.** With that access comes responsibility to use those resources properly and for their intended purpose. The Pennsylvania College of Technology Acceptable Use Policy states, in part, that students may not:

- ♦ Give or publish a password, identifying code, personal identification number or other confidential information about a computer, computer system, network or email account, database, or any other College IT resource.
- ♦ Use any College IT resource for commercial, political, or illegal purposes; personal financial gain; or harassment of any kind.
- ♦ Display obscene, lewd, or otherwise offensive images or text.
- ♦ Gain access by using another person’s name, password, access codes, or personal identification.
- ♦ Attempt (even if unsuccessful) to gain unauthorized access by circumventing system security, uncovering security loopholes, or guessing passwords/access codes.

**PLEASE NOTE: Penn College’s policy on Academic Dishonesty will be followed.**

**Pennsylvania College of Technology takes academic dishonesty very seriously.** See below for an explanation of some key terms, according to Penn College policy.

- ♦ **Academic Dishonesty:** deceptive behavior or actions with regard to data, records, submitted works, exams, or other materials related to participation in a course or other academic exercise; these actions include, but are not limited to, cheating, plagiarism, multiple submissions, misrepresentation of academic records, falsification of any course related documents, facilitation of academic dishonesty by others, unfair advantage, violation of known safety requirements and ethical misconduct.
- ♦ **Cheating:** using or attempting to use unauthorized assistance (e.g., asking someone for an answer during a test, copying answers from another student’s test, etc.), using unauthorized study aids during an exam (e.g., “cheat sheets” or books/notes), or submitting the work of another as one’s own.
- ♦ **Plagiarism:** using the idea, data, or language of another without specific or proper acknowledgment.
- ♦ **Multiple submission:** submitting (or attempting to submit), without prior permission of the current faculty member, any work previously submitted to fulfill another academic requirement (e.g., paper or project submitted for another course).
- ♦ Upon admission to Penn College, students make the unqualified commitment to responsible, ethical academic conduct. Academic dishonesty, as defined above, is contrary to the mission of the College and to the best interest of its members. Therefore, **students are expected to represent themselves, their work, and the work of others with honesty and integrity.**
- ♦ Charges of academic dishonesty will be taken seriously. **Students found guilty of academic dishonesty will be subject to action and penalties as the circumstances justify, including suspension or expulsion from the College.**

**PLEASE NOTE:** Consequences will follow Penn College’s guidelines for Academic Dishonesty.

## ACADEMIC DISHONESTY

It's always in your best interest to commit your time and effort to your coursework so that you get the best result. If you must drop a Penn College Dual Enrollment course, however, here's what you need to know:

- ◇ Talk to your teacher and your school counselor about your options before you make the choice to drop the course or stay.
- ◇ **An "F" or a "W" in a Penn College Dual Enrollment course is an "F" or "W" on an official college transcript.** An "F" or "W" can affect your GPA and your ability to get financial aid once you enroll in college after high school. For those seeking entry into selective admissions programs (often in health science majors), an "F" or "W" may impact your eligibility and ranking for selection.
- ◇ **If you want to withdraw from a Penn College Dual Enrollment course, there are deadlines to remember.** Students can withdraw from a course before a certain point in the semester without academic penalty. After that point, there is no dropping allowed, and the grade earned is the grade on the student's official transcript.
  - ◇ **Drop without a "W":** A student may drop a class without a "W" grade. The course will not be recorded on the transcript.
  - ◇ **Drop with a "W":** A student may drop a class with a "W" grade. The "W" is recorded on the transcript.
  - ◇ **No Dropping Allowed:** Students may no longer drop or withdraw; the final course grade will be recorded on the transcript.
- ◇ **If you move away from your district or CTC while taking a Penn College Dual Enrollment class, you will be withdrawn from the course without penalty.**
  - ◇ The course will not appear on your official Penn College transcript.
  - ◇ Signatures from the high school teacher and Point of Contact are required to drop the course and verify your change in location.

- ◇ There are times when student behavior warrants immediate termination from the Penn College Dual Enrollment program, and **Pennsylvania College of Technology reserves the right to remove students from the program in the following situations:**

- ◇ Excessive absences, even due to medical and/or excused issues
- ◇ Failure to demonstrate safe practices
- ◇ Academic dishonesty
- ◇ Improper use of Penn College technology and/or other resources
- ◇ Disciplinary issues and/or improper student conduct

At most colleges, students pursuing healthcare-related majors are admitted based on selective admission criteria. This means that students who have reached a certain level of academic performance are ranked against each other, with the top 20 to 40 students being selected to enter the program.

Math and science courses are key to the selection process for healthcare programs at Penn College. For example, courses such as MTH123, MTR104, and BIO103 (if required by the program) need to be completed with at least a C for the student to be eligible to be ranked.

Nursing & Health Science majors require a limited number of pre-program courses and have specific course requirements during each in-program semester; therefore, the more courses taken via dual enrollment, the fewer you will need to complete once in college. This may result in part-time enrollment for one or more semesters of college.

For many of the College's Nursing & Health Sciences majors, students who need to retake math and science courses to earn a higher grade are typically ranked lower compared to candidates who do well on the first attempt at the courses. The bottom line for you is to work hard to earn a high grade now! It will pay off later!

*Students interested in a Nursing & Health Sciences major are encouraged to contact the school to learn more about the ranking and selection process.*

- 2 Under Academics, go to **My Grades** or the **unofficial transcript**.

- 3 Choose the appropriate semester and submit.

- 3 Fill out all information and submit.

All transcript requests must come from the student. We will not release transcripts to parents or third parties without permission, except in the case of subpoena or law enforcement directive.

Telephone requests are not accepted.

All grade holds must be cleared from your record before transcripts will be released.
