President Reed shared the following with the group:

- Graduate placement rate stands at just over 96% with graduates reporting starting salaries as high as \$125,000.
- US News Rankings: The College ranked in the top 10 in five separate categories—top five in best public institutions, top 10 overall, top five innovation, teaching, and supporting our veterans.
- PSU President Neeli Bendapudi spent a day on our campus to learn more about our mission.
- Incoming class enrollment: 12% increase in new students in comparison to last year, including over 300 students who transferred in from other institutions.
